THIS IS THE ONLY MEDICALLY ORIENTED VOCATIONAL REHABILITATION PROGRAM IN THE AREA. MEDICAL THERAPISTS AND LICENSED COUNSELORS PROVIDE WORK-ORIENTED NEURO-REHABILITATION ACTIVITIES SUCH AS PHYSICAL AND COGNITIVE ASSESSMENTS, ASSESSING WORK CAPABILITIES, TREATMENT TO IMPROVE PHYSICAL AND MENTAL STAMINA, NEUROPSYCHOLOGICAL EVALUATIONS, INDEPENDENT LIVING ASSESSMENTS, COMPENSATORY STRATEGY TRAINING, ACCOMMODATION AND TECHNOLOGY TRAINING, DISABILITY ADJUSTMENT COUNSELING AND BEHAVIOR THERAPIES. AFTER THE PERSON MEETS THEIR REHABILITATION GOALS, EMPLOYMENT SPECIALISTS CONTINUE TRAINING AS NEEDED IN OTHER AREAS TO
